To best support you in the registration process, we've designed this info sheet to help you organize the things you need to successfully enroll in our Day Camp program. Below are some important facts and dates.

#### Important Dates to Remember

- Solution Comp Open Houses: Jan 25; Mar 21; Apr 18, May 16; Jun 6 takes place at the YMCA
- Day Camp Session Dates: S1: Jun 29-Jul 10\*; S2: Jul 13-Jul 24; S3: Jul 27-Aug 7; S4: Aug 10-Aug 21 \* <u>There will be no Day Camp on Friday, Jul 3.</u>
- Payment Due Dates: <u>Jun 6 for all 4 sessions</u>.
- **Day Camp Family Orientation: Jun 6 1:00pm-2:00pm; Jun 24 6:00pm-7:00pm** takes place at the YMCA

### Things to Remember

- Deposit: A \$250 non-refundable deposit per 2-week session is due at the time of registration. This will secure your slot.
- Refund Policy: Credit/Refund requests must be submitted by <u>Sunday, Jun 14</u>. Credits/Refunds are granted for medical reasons, supported by a doctor's note and approved by the Director. Please note, all requests must be submitted with a credit request form (located at Member Services) and supporting documentation.
- Discounts: Take advantage of our 10% Early Bird discount by paying off your entire balance by Saturday, Apr 18. One discount per family.
- Medical Forms: Medical forms must be completed by a physician and include a signature and stamp. Medical forms must be submitted by Wednesday, Jun 24.
- Change Form: Any families interested in adding, dropping, or switching their Day Camp session will need to fill out an official Change Form, available at Member Services.
- Financial Assistance: Financial Assistance inquiries should be directed to Nanda Khan, dkhan@ymcanyc.org.

## <u>Things to Know</u>

- SEITs: Have a SEIT or Therapist accompanying your child during Day Camp? Please have them email their DOE clearance and certificates to Shonnell Griffith, sgriffith@ymcanyc.org, <u>at least 2 weeks prior to your child's start date</u>. Please note, without clearance, they will not be able to provide services during our Day Camp program.
- Grouping Requests: All grouping requests must be submitted by <u>Jun 6</u> to mcburneyycamp@ymcanyc.org. Please note, our traditional Day Camp is broken up by age, so children must be the same age and registered in the same session and Day Camp program.
- Arrival/Dismissal: Our Day Camp operates out of PS41, <u>drop off and pick up is at PS41</u>, not at the Y.
- Camp T-shirt: Each camper will receive 2 camp T-shirt on their 1<sup>st</sup> day of Day Camp along with a camp backpack. T-shirts must be worn daily. Additional t-shirts can be purchased at Member Services beginning Jun 29. 1 for \$10 or 3 for \$25.
- Lunch: Lunch is provided by the Department of Education (DOE) daily except for trip days on Tuesdays & Thursdays. Please provide camper with 2 snacks daily.
- Swim Days: All of our Camps have instructional swim twice per week for 45mins each day.

I further agree that my name may be used to identify me as a subject of any Recordings featuring my image, likeness, and/or voice.
- 2. I understand that the YMCA will own all rights in the Recordings of me that the YMCA or a YMCA contractor takes or records ("YMCA Recordings"), and that the YMCA will have the exclusive right to use, or allow others to use, such YMCA Recordings in any medium for any purpose consistent with the YMCA's charitable mission as determined by the YMCA.
- 3. I understand that the Media will own all rights in the Recordings of me that the Media takes or records ("Media Recordings"), and that the Media will have the exclusive right to use, or allow others to use, such Media Recordings in any medium for any lawful purpose.
- 4. I understand that I am waiving any and all rights that may preclude the YMCA's or the Media's use of the Recordings as described above.
- 5. I acknowledge that neither the YMCA nor the Media has any obligation to use any Recordings of me or to use such Recordings for any particular purpose.
- 6. I understand that I will receive no monetary payment or other compensation in exchange for the rights to use Recordings of me.
